



The GEO Group Declares Quarterly Cash Dividend of \$0.62 Per Share

The quarterly cash dividend will be paid on February 27, 2015 to shareholders of record as of the close of business on February 17, 2015.

George C. Zoley, Chairman and Chief Executive Officer of GEO, said: "We are pleased to declare our quarterly cash dividend of \$0.62 per share, or \$2.48 per share annualized, which is indicative of our continued commitment to return value to our shareholders."

Following its previously announced acquisition of assets from LCS Corrections Services, GEO's worldwide operations will include the ownership and/or management of 106 facilities totaling approximately 85,500 beds, including projects under development, with a growing workforce of approximately 19,000 professionals.
